In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

I POLITELY GAVE HIM MY OPINION A FEW TIMES, AND ULTIMATELY TOLD HIM THAT WASN'T THE KIND OF BUSINESS WE WERE INTERESTED IN DOING AND SUGGESTED HE STICK WITH THE INVESTMENTS WE HAD CHOSEN. AT NO TIME DID I REFUSE TO TRANSFER HIS ACCOUNTS OUT OF A.G. EDWARDS AND AT NO TIME DID WE RECEIVE TRANSFER PAPERWORK FROM ANY OTHER INSTITUTION.
