What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CLIENT OWNED TWO VARIABLE ANNUITY POLICIES WHICH WERE 100% IN MONEY MARKET FUNDS DURING MUCH OF THE 1998-99 RUNUP IN THE MARKET. AFTER A 3-12-2000 CONVERSATION WITH THE CLIENT, REP MADE A SERIES OF ASSET ALLOCATION CHANGES TO THE CLIENT ACCOUNT. AFTER THE MARKET DOWNTURN IN APRIL, 2000, CLIENT CONTACTED REP DISAVOWING AUTHORIZATION. THESE WERE NOT COMMISSIONED TRANSACTIONS, BUT MERELY ASSET ALLOCATION. THE LOSS WAS \$60,331.84, DUE TO MARKET ACTION. REP CHOSE NOT TO SEEK LEGAL RECOURSE IN ORDER TO QUICKLY END DISPUTE.
