What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I HAVE KNOWN THE [CUSTOMERS] FOR 41 YEARS, AS THEY ARE FORMER NEIGHBORS OF MINE, AND I'M DEEPLY UPSET ABOUT THIS COMPLAINT. THE [CUSTOMERS] BECAME CLIENTS OF MINE DURING THE SUMMER OF 2005 WHILE I WAS ASSOCIATED WITH A PREVIOUS FIRM. THEY AGREED TO MOVE WITH ME IN APRIL OF 2008, WHEN I OPENED MY OWN ADVISORY FIRM, A MOVE THAT WAS FINALIZED DURING EARLY AUGUST OF 2008.

AFTER COMPLETING THE TRANSFER IN AUGUST, [CUSTOMER] INFORMED ME THAT HE WAS NOT HAPPY WITH MARKET RETURNS AND WANTED TO TERMINATE MY MANAGEMENT AGREEMENT, CLOSE THE TRUST ACCOUNTS, AND TRANSFER THE IRA ASSETS TO A NEW CUSTODIAL FIRM FOR HIM TO MANAGE. [CUSTOMER] SAID THAT HE WANTED THE TRUST ACCOUNTS GRADUALLY CLOSED WITH AN EYE TOWARDS CAPITAL GAINS TO MINIMIZE ANY TAX IMPLICATIONS. AT NO POINT DID EITHER [CUSTOMER] OR [CUSTOMER] USE THE WORDS "AS SOON AS POSSIBLE" OR "IMMEDIATE" IN RELATION TO CLOSING AND TRANSFERRING THE TRUST ACCOUNTS. IN ADDITION, [CUSTOMER] INFORMED BY PHONE THAT HE WOULD BE LIQUIDATING AND TRANSFERRING THE IRA ASSETS. SUBSEQUENTLY, I RECEIVED E-MAIL CONFIRMATION FROM MY CUSTODIAL PLATFORM THAT [CUSTOMER] LIQUIDATED THE IRAS.

I FULLY COMPLIED WITH THE [CUSTOMERS] INSTRUCTIONS ON CLOSING THEIR TRUST ACCOUNTS BEGINNING IN AUGUST AND FINISHING IN LATE OCTOBER.
