CLIENT ALLEGES THAT THE RR MISINFORMED CLIENTS REGARDING THE TAX CONSEQUENCES OF THE WITHDRAWAL. CLIENTS WERE REFERRED TO THEIR CPA FOR TAX CALCULATIONS. CLIENTS MISINFORMED BOTH CPA & RR ABOUT DEFERRED GAINS FROM ORIGINAL FIDELITY ANNUITY THAT EXCHANGED INTO A VALIC NON-QUALIFIED DEFERRED ANNUITY. THE PLAINTIFFS ACCEPTED THE INSURER'S \$20,000 SETTLEMENT OFFER AND THIS MATTER HAS BEEN RESOLVED. WITH PREJUDEMENT INTEREST THE AMOUNT SOUGHT AGAINST ME WAS WELL IN EXCESS OF \$50,000. ACCORDING TO MY ATTY RICHARD NEUMEIER THIS CASE WAS WITHOUT MERIT. THE E&O INSURANCE COMPANY NONETHELESS DECIDED TO SETTLE THE CASE ESSENTIALLY FOR WHAT IS CALL IN THE INDUSTRY "THE COST OF DEFENSE"
