IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: Hohimer Wealth Management LLC

Allegations: Some time around April 23, 2026, the Firm received a written complaint by email from a client of the Firm's Investment Advisor Representative ("IAR"). The customer's account was opened with the Firm on or about July 2025 and was subsequently funded by an in-kind transfer of a concentrated equity position in CRDO (the "Position") on or about February 2026.

The customer alleges that, at the time of transfer and again by text message on or about [date], he verbally instructed the RR to refrain from selling the Position and to hold it until it reached \$200 per share, while permitting trading in other securities held in the account. Between [first sale date] and [last sale date], the RR executed a series of sales of the Position. The customer alleges those sales were unauthorized, contrary to his instructions, and caused losses and lost appreciation of approximately \$500,000.

The Firm acknowledged the complaint in writing on April 24, 2026, issued a Legal Hold the same day, and opened an internal investigation, which remains ongoing.

Alleged Damages Amount Explanation (if amount not exact): The client alleges that the advisor executed the sale of a specific equity position against their instructions. The alleged damage amount represents the client's calculated missed unrealized gains had the position been held.

The Firm and the Representative strongly deny the allegations. An internal investigation into the customer's claims is currently ongoing. Based on the evidence reviewed thus far, the client's executed Investment Policy Statement contains no special instructions, hold mandates, or restrictions regarding the security in question. Furthermore, a preliminary review of official firm correspondence has not identified any emails or approved written directives from the client imposing such a restriction.

Pursuant to the firm's governing documents, including the Form ADV and the signed Investment Management Agreement, any account restrictions or modifications to investment objectives must be submitted in writing to the firm's official email address. Text messaging is not an authorized, approved, or recognized channel for communicating trade instructions or account restrictions to the firm. Based on the findings to date, the firm maintains that the transactions were executed suitably and strictly within the discretionary authority legally granted by the client. The firm will supplement this disclosure as necessary upon the conclusion of its review.
