IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Regulator Statement

On September 17, 2018, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Stephen R. Williams. Mr. Williams neither admitted nor denied the findings but consented to the entry of findings by the Office. The Office found that Stephen R. Williams failed to: send itemized invoices; establish, maintain and enforce written supervisory procedures; and comply with the safekeeping requirements of the Florida Securities and Investor Protection Act, Chapter 517, F.S. Pursuant to the Final Order, Mr. Williams agreed to cease and desist from all present and future violations of Chapter 517, F. S. and the administrative rules thereunder; to pay an administrative fine in the amount of \$11,000.00 jointly and severally with Stephen R. Williams Investment Advisor, Inc.; and to a 30-day suspension, during which time Stephen R. Williams is prohibited from selling or offering for sale any securities in or from offices in this state, or selling securities to persons in this state from offices outside this state, by mail or otherwise.
