THE FIRM SETTLED THE MATTER FOR \$300,000.00 TO AVOID THE EXPENSE OF FURTHER ARBITRATION AND LITIGATION.**THE CASE SETTLED NOT BECAUSE OF TRADING ACTIVITY IN THE ACCOUNT BUT BECAUSE A THIRD PARTY TRUSTEE REMOVED FUNDS FROM THE ACCOUNT. THE BENEFICIARY SOUGHT TO HOLD THE FIRM RESPONSIBLE FOR NOT STOPPING THE OUTFLOW OF FUNDS. THE FIRM AGREED TO SETTLE FOR \$300,000 TO AVOID THE RISK AND EXPENSE OF FURTHER LITIGATION. I WAS NOT ASKED TO APPROVE OF THE SETTLEMENT OR TO CONTRIBUTE TO THE SETTLEMENT IN ANY AMOUNT.
