What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: [customer] CFO, [3RD PARTY], INSTRUCTED [OTHER FIRM EMPLOYEE] TO LIQUIDATE THE ACCOUNT ON JUNE 22, 2004. THE ACCOUNT WAS LIQUIDATED AND THE CLIENT INFORMED ON JUNE 24TH. ON JULY 7, 2004 SCHOOL PRESIDENT AND CEO, [3RD PARTY] REQUESTED A WRITTEN EXPLANATION AS TO WHY THE ACCOUNTS WERE LIQUIDATED. SUBSEQUENTLY, ON JULY 14, IN A CONFERENCE CALL BETWEEN [3RD PARTY], [3RD PARTY], [OTHER FIRM EMPLOYEE], AND MR. NOONAN, [3RD PARTY] INDICATED THAT THE BOARD HAD NOT INTENDED TO LIQUIDATE AND WANTED THE ASSETS RESTORED. ACTING ON WHAT WAS BELIEVED TO BE NEW INSTRUCTIONS, THE LIQUIDATION WAS REVERSED. ON JULY 16, [3RD PARTY] CONTACTED THE BRANCH MANAGER, [BRANCH MANAGER] AND SAID THAT HE HAD NOT INTENDED HIS COMMENTS ON JULY 14 TO BE AN ORDER TO REVERSE THE TRANSACTION. IN THE INTEREST OF CLIENT RELATIONS, THE TRANSACTION WAS REVERSED AGAIN WITH THE DEFICIT BEING PAID JOINTLY BY THE BROKERS. ALLEGED DAMAGES - UNSPECIFIED
