WE DISCUSSED THE INCREASED DEBIT BALANCE, THE RISKS AND MERITS OF HIS CURRENT PORTFOLIO, AND WHAT POSITIONS SHOULD BE REDUCED OR INCREASED. HE DECIDED TO RESTRUCTURE HIS PORTFOLIO AS WE DISCUSSED AND I ENTERED ORDERS AS HE INSTRUCTED. AT NO TIME DID I ENTER ANY TRADES THAT WERE NOT DECIDED UPON BY CUSTOMER PRIOR TO THEIR BEING ENTERED.
