What is included in a IAPD report?

Where did this information come from?

Broker Statement

I deny the allegations that I did not follow the client's instructions when I was asked to sell all the Energy Bonds in the clients portfolio. When I received the client's request to review his portfolio for Energy Bonds, the client had over 1400 different bonds. In my opinion the type of Energy bond he was referring to were Energy Production & Exploration such as the Marathon Oil, Valero, Chesapeake Energy, and Massey Energy and the Ohio Water bond in question even though issued by First Energy Solutions is a Utility bond, not an Energy bond. In my review, Moody's considers Utilities and Energy to be separate categories, and the research reports written for this bond were written by Moody's Utility analysts. Furthermore, this client owns many municipal bonds issued by Utilities, and back on 8/29/15, when I received the instructions regarding the Energy Bonds, we did not get bids or discuss selling any of them. The client even after August 29th, bought other municipal bonds issued by Utilities. Two (2) years after the client purchased the Ohio Water bond, First Energy Solutions announced news that made this bond drop significantly. It was at this time the client called and was upset that the Ohio Water Bond had not been sold. I tried to explain to him that this bond was considered a Utility bond and not an Energy bond, but he was not satisfied. This matter was settled as a business decision and accommodation in the interest of "good client relations". I maintain that there was no wrong doing on my part and I acted in the best interest of my client by making sure that all the other Energy Bonds were sold.
