IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

[CUSTOMER] ENTERED AN ORDER TO PURCHASE TWO (2) OEXWD PUT OPTIONS AND TEN (10) OEXKF CALL OPTIONS. BASED UPON HER CONVERSATION WITH [CUSTOMER], LYNN MOELLER DID NOT BELIEVE THAT [CUSTOMER] WISHED TO PURCHASE THE NOVEMBER \$320 PUT OPTIONS WHICH WERE 100 POINTS IN THE MONEY AND THE NOVEMBER \$330 CALL OPTIONS WHICH WERE 110 POINTS OUT OF THE MONEY. AS A RESULT, MR. MOELLER ENTERED AN ORDER TO PURCHASE TWO (2) OEXWD (NOVEMBER \$220 PUTS) AND TEN (10) OEXKF (NOVEMBER \$220 CALLS). THE PUTS WERE PURCHASED AT \$72 AND SOLD AT \$27, ALL ON OCTOBER 20, 1987. THE RESULTING LOSS WAS \$29,136.50. [CUSTOMER] CONTENDED THAT HE HAD IN FACT INTENDED TO PURCHASE THE NOVEMBER \$330 CALLS AND THE NOVEMBER \$330 PUTS WHICH, IF THOSE ORDERS HAD BEEN EXECUTED, WOULD HAVE RESULTED IN A LOSS OF \$6,301.85. THE MATTER WAS SETTLED FOR \$19,136.50. THIS MATTER WAS SETTLED ON DECEMBER 15, 1987.
