Broker Statement MERRILL LYNCH AND MR. CASO DENIED THE CUSTOMER'S ALLEGATION IN THEIR ENTIRETY. THE PURCHASE IN QUESTION TOOK PLACE OVER 6 1/2 YEARS AGO IN FEBRUARY 2002 AND WAS NEVER A PRIOR ISSUE. THE BOND PURCHASE WAS MADE TO PROVIDE THE CUSTOMER WITH DESIRED INCOME (7.25% ANNUAL INCOME). CUSTOMER MADE AN INFORMED DECISION TO INVEST IN THE BOND IN QUESTION.
