IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

pursuant to a tender offer. The client had trading authorization over his and his wife's account holding a security that was the subject to a tender offer unless the holder affirmatively declined the offer. After discussing the issue with the client, I processed the instruction to decline the offer for his account but did not realize that his instruction was intended to cover the investment in his wife's account as well. The client realized the error a few months after the transaction but did not raise it while the mistake worked in their favor. Once the stock appreciated, he complained about the error to request that the tender be reversed. The firm agreed to reverse the transaction for the client.
