IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: CIBC WORLD MARKETS CORP.

Allegations: UPON RECEIVING NOTICE OF A TENDER OFFER FOR SHARES OF BOGEN COMMUNICATIONS, MR. FRANZBLAU AND HIS PARTNER ATTEMPTED SEVERAL TIMES TO CONTACT THE CLIENT, TO INQUIRE WHETHER HE WISHED TO TENDER HIS SHARES. AT THE CLOSE OF THE TENDER PERIODS, MR. FRANZBLAU AND HIS PARTNER NOTED THAT THE TENDER WAS HIGHER THAN THE CURRENT PRICE OF THE STOCK. ACCORDINGLY, THEY TENDERED THE CLIENT'S SHARES ON HIS BEHALF. SEVERAL DAYS LATER, THE CLIENT INFORMED MR. FRANZBLAU AND HIS PARTNER THAT HE HAD NOT WANTED HIS SHARES TO BE TENDERED. THE TENDER WAS IMMEDIATELY UNWOUND, AT A COST OF APPROXIMATELY \$16,000.
