THE CLIENT'S ACTIONS ARE DIRECTED AT MORGAN KEEGAN AND THE BELIEF THAT MORGAN KEEGAN MANAGEMENT DID NOT ACT IN GOOD FAITH IN THE HANDLING OF THE SALE OF MORGAN KEEGAN FUNDS, AS WAS DEEMED IN THE \$200+ MILLION SETTLEMENT RELATED TO THIS SPECIFIC FUND. ALL FINANCIAL ADVISORS WHO USED THIS FUND IN THEIR PORTFOLIOS ACTED AS A CONDUIT OF MORGAN KEEGAN IN THE SALE OF MORGAN KEEGAN FUNDS RELYING ON MORGAN KEEGAN MANAGEMENT TO BE DOING ITS APPROPRIATE AND ACCURATE DUE DILIGENCE. THIS SETTLEMENT DOES NOT REFLECT ANY ACKNOWLEDGEMENT OR ADMISSION OF ANY LIABILITY OR MISCONDUCT ON MY PART WHATSOEVER. I WAS NOT ASKED TO PERSONALLY CONTRIBUTE ANY MONETARY AMOUNT TOWARDS THE SETTLEMENT OF THIS CASE.
