**Broker Statement** DURING THE ASIA CURRENCY CRISIS IN THE 4TH QUARTER OF 1998, CLAIMANTS TRANSFERRED THEIR ACCOUNTS TO PAINE WEBBER TO HELP THEIR SON-IN-LAW EARN NEW ACCOUNT BONUSES. THEIR ACCOUNTS LOST MONEY DURING THE TRANSFER. IN AN ATTEMPT TO RECOVER MARKET LOSSES, CLAIMANTS ALLEGED PIPER JAFFRAY DID NOT REBATE A 12B-1 MUTUAL FUND FEE THAT WAS IN FACT REBATED TO CLAIMANTS. ### Broker Statement

UPON INFORMATION AND BELIEF, CLAIMANTS WERE TRADING STOCKS AND OPTIONS ON MARGIN DURING THE OCTOBER 19, 1987 STOCK MARKET CRASH AND RECEIVED MARGIN CALLS THAT RESULTED IN SECURITIES LIQUIDATIONS AT LOSSES. CLAIMANTS WERE CLIENTS OF ANOTHER SMITH BARNEY BROKER, [OTHER FIRM EMPLOYEE] AT THE TIME OF THE LOSS. ALL 22 CLAIMS OF CLAIMANTS WERE DISMISSED. ALL RESPONDENTS WERE FOUND JOINTLY AND SEVERALLY LIABLE TO PAY CLAIMANT'S MOTHER, THE SUM OF \$9,199.60 PLUS INTEREST FOR FAILING TO MEET WITH HER AND INSTEAD RELYING ON HER SON USING HER POWER OF ATTORNEY. VINCENT ROSSI WAS NOT ASKED AND DID NOT CONTRIBUTE TO THE AWARD.
