IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

During the COVID-19 pandemic, while working from home pursuant to my former Firm's policy, I sent a document from my firm email account to my personal email account so that I could print the document in my home office in order to service my clients' needs during a fast-moving, turbulent market. However, this printing took place without software supplied by my former Firm. No person apart from me had access to my client information and no person apart from me ever saw the information that is at issue. I immediately informed my manager that I had emailed the document for printing at home, and he told me he did not see any problem with what I had done. Nevertheless, my former Firm used this technical violation of firm



policy to terminate my employment for what, in fact, was nothing more than an internal personality dispute. I have had a 37-year career in the securities industry with a spotless compliance record, until now. At no time in my career, including on the occasion referenced above, have I ever put any client information at risk. At all times, including when I sent the email described above, I have acted in the best interests of my clients.
