**Regulator Statement**

On September 9, 2021, the Office of Financial Regulation (Office) entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Robert Andrew Moro (Moro). Moro neither admitted nor denied the allegations but consented to the entry of findings by the Office. The Office found that Moro violated section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. Moro agreed to Cease and Desist from violations of Chapter 517, Florida Statutes, and the Office's rules promulgated thereunder, and to pay an administrative fine in the amount of \$13,125. The Office agreed to approve Moro's application as an associated person (RA) with Eagle Strategies LLC effective September 9, 2021.

**Allegations:** The settlement was the result of the firm's error in failing to timely register Moro as an investment adviser in the state of Florida. Moro had taken the necessary steps to ensure he was properly registered in Florida, but due to an error by the firm, the required filing was not completed. Moro relied on the firm to ensure he had been properly registered. Moro had the necessary qualifications, and he was approved to act as an adviser in other states. Without admitting or denying the findings, Moro consented to the entry of an Order by the Florida Office of Financial Regulation (Office) for violating section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. The Office agreed to approve Moro's application as an associated person (RA) with Eagle Strategies LLC effective 9/9/2021. This matter did not involve any concerns about Moro's conduct as an adviser, and there was no impact to any clients. The



fine was paid on Moro's behalf by Eagle Strategies, because the firm and not Moro was at fault.
