AN EXPLANATION OF DIVIDENDS, MATURITY DATE, AND PRICE FLUCTUATION WAS GIVEN TO THE CLIENT PRIOR TO OUR CLOSE. THE BROKER CONSTANTLY UPDATED REGARDING DIVIDEND PAYMENTS, PERIODIC RATE CUTS, & PRICE FLUCTUATIONS ESPECIALLY, DURING 1994 AND 1995. CLIENT SOLD HER SHARES PRIOR TO MATURITY ON 11/1/95. IF CLIENT HAD HELD ACCORDING TO HER INITIAL & CONSISTENT OBJECTIVES, A LOSS MIGHT NOT HAVE BEEN INCURRED. THE FUND'S OBJECTIVE CONTINUES TO BE TO RETURN \$10 PER SHARE ON 12/31/02.
