IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	MR. GOOCH OWNED AND OPERATED A MOBILE HOME MANUFACTURER CO. IN MINDEN, NEBRASKA. INITIAL FUNDING WAS OBTAINED FROM A LOCAL BANK. HEAVY SNOWFALL DELAYED SHIPMENT OF UNITS RESULTING IN A NEED FOR A LINE OF CREDIT. THE LOCAL BANK WOULD ONLY EXTEND THE FINANCING IF THEY WERE BROUGHT IN AS A PARTNER. FINANCING WAS OBTAINED FROM A NEIGHBORING BANK INSTEAD. THE LOCAL BANK WAS UPSET THYE WEREN'T BROUGHT ON AS A PARTNER AND CALLED OUTSTANDING NOTES DUE. THEY OFFERED THE CHOICE OF PAYING OFF THE NOTES OR SELLING THE BUSINESS TO THEM. MR. GOOCH SOLD THE BUSINESS, RECEIVED PAYMENT, AND WAS RELEASED FROM ALL LIABILITIES. THE BANK WAS UNABLE TO RUN THE BUSINESS AND IT WAS CLOSED. CREDITORS CAME AFTER THE BANK FOR ACCOUNTS PAYABLE, AND AS A SMOKE SCREEN, THE BANK DECLARED THAT MR. GOOCH EMBEZZLED FUNDS. THE LOCAL BANK HAD POLITICAL CLOUT IN THE SMALL COMMUNITY AND PREVAILED WITH THE COUNTY TO FILE CHARGES. AT THE TIME, MR. GOOCH WAS LIVING IN HOUSTON, TX. AT THE FIRST COURT DATE, THE JUDGE DISMISSED THESE CHARGES, ACKNOWLEDGING THERE WAS NO CASE OR EVIDENCE.
