IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations:	DUE TO AN ADMINISTRATIVE ERROR BY A FORMER MEMBER OF BEACON FINANCIAL ADVISORS, LTD. (BEACON), BEACON AND MARCEL HEBERT, BEACON'S CURRENT PRESIDENT (THEN VICE PRESIDENT), FAILED TO RENEW THEIR REGISTRATIONS WITH THE TEXAS STATE SECURITIES BOARD FOR 1994, WHICH MEANT THAT THEY RECEIVED NO RENEWAL NOTICES FOR 1995 OR 1996 AND REMAINED UNREGISTERED DURING THOSE YEARS. WHEN BEACON AND HEBERT DISCOVERED THIS ERROR,



IT VOLUNTARILY CONTACTED THE TEXAS STATE SECURITIES BOARD, EXPLAINED THAT IT HAD INADVERTENTLY PERMITTED THE REGISTRATION TO LAPSE AND AGREED TO THE ENTRY OF A CONSENT ORDER WHICH PROVIDED FOR CERTAIN SANCTIONS AGAINST ADVISORY FIRM AND MARCEL HEBERT. THE CONSENT ORDER WAS ENTERED BY THE TEXAS SECURITIES COMMISSIONER ON APRIL 8, 1996. THE CONSENT ORDER GRANTED THE REGISTRATION OF BEACON AND MARCEL HEBERT.
