IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

UNRESTRICTED LICENSE AND RE-ISSUED A RESTRICTED LICENSE IN LIEU THEREOF DUE TO THE UNREPORTED MISDEMEANOR CHARGE OF 2005. CALIFORNIA DOI CODE SECTION 1742 ALLOWS THE HOLDER OF A RESTRICTED LICENSE TO ACT IN THE SAME CAPACITY AND BE SUBJECT TO THE SAME PROVISIONS AS THE HOLDER OF A UNRESTRICTED LICENSE. THE SUPERIOR COURT OF CALIFORNIA WAS PETITIONED FOR RELIEF OF THE MISDEMEANOR CHARGE ON 5/27/2010 DUE TO SUCCESSFUL PROBATIONARY TIME HAVING BEEN SERVED WITH NO FURTHER VIOLATIONS. ADDITIONALLY, THE CALIFORNIA DOI WAS PETITIONED ON 5/27/2010 FOR REMOVAL OF THE RESTRICTED LICENSE AND REINSTATEMENT OF AN UNRESTRICTED LICENSE DUE TO THE MINIMUM 2 YEAR PROBATION HAVING BEEN SERVED WITH NO FURTHER VIOLATIONS.
