IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THIS ARBITRATION CLAIM ARISES OUT OF A FAMILY DISPUTE BETWEEN TWO CO-TRUSTEES RELATING TO THE OPERATION OF NON-DISCRETIONARY BROKERAGE ACCOUNTS. THE CLAIM ASSERTS A BREACH OF FIDUCIARY DUTY BY THE REGISTERED REPRESENTATIVE BASED ON MESIROW FINANCIAL FOLLOWING THE WRITTEN INSTRUCTIONS OF A CO-TRUSTEE WITH FULL INVESTMENT AND TRADING AUTHORITY, OVER A TEN-YEAR PERIOD FROM 2004 TO 2014. SPECIFICALLY, THE COMPLAINT ALLEGES THAT THE REGISTERED REPRESENTATIVE BREACHED AN ALLEGED FIDUCIARY DUTY BY FOLLOWING THE DIRECTION OF A CO-TRUSTEE TO ESTABLISH AND MAINTAIN MARGIN LOANS AND BY EXECUTING REQUESTS TO WITHDRAW FUNDS FOR INVESTMENTS AWAY FROM MESIROW FINANCIAL INC. THE REGISTERED REPRESENTATIVE BELIEVES THE CLAIMS ARE TOTALLY WITHOUT MERIT AND INTENDS TO FULLY REFUTE THEM AT THE ARBITRATION HEARING.
