Broker Statement This Oil/gas program had its due diligence done by Lincoln Financial Securities Corporation, my former broker/dealer, and the parameters for these programs were:
 1. Prospects must be accredited investors. (One must have a minimum annual income of a certain amount/Net Worth)
 2. Lincoln allows no more than 10% of one's net worth to be allocated to the investment due to the speculative, high-risk nature of the programs.
 3. Risks must be explained to the client, and they must sign off that they



understand the risks.
 4. A prospectus must be given to the client prior to the investment.
 The client participated in the program, and it represented less than 3% of his Net Worth.
 Lincoln reported on my U5 that I had recommended an unsuitable investment to my accredited investor. I disagree with the statement that this was an unsuitable investment, as I had followed the firm's parameters. The client was a 30-year employee of the oil/gas business and was aware of the risks involved.
