COMPLAINT NO. C8A960024 FILED APRIL 17, 1996 BY DISTRICT NO. 8 AGAINST RESPONDENT DONALD PETER CARNAGHI ALLEGING VIOLATIONS OF ARTICLE III, SECTIONS 1 AND 40 OF THE RULES OF FAIR PRACTICE IN THAT RESPONDENT CARNAGHI PARTICIPATED IN PRIVATE SECURITIES TRANSACTIONS AND FAILED AND NEGLECTED TO GIVE HIS MEMBER FIRM PRIOR WRITTEN NOTICE OF, AND TO OBTAIN FROM THE MEMBER PRIOR WRITTEN AUTHORIZATION TO ENGAGE IN SUCH ACTIVITIES; AND, FAILED TO RESPOND TO NASD REQUESTS FOR INFORMATION MADE PURSUANT TO ARTICLE IV, SECTION 5 OF THE RULES OF FAIR PRACTICE.

AMENDED COMPLAINT FILED JANUARY 15, 1997 ALLEGING VIOLATIONS OF NASD RULES 2110 AND 3040 IN THAT RESPONDENT CARNAGHI PARTICIPATED IN THE OFFER AND SALE OF SECURITIES ON A PRIVATE BASIS AND IN CONNECTION THEREWITH FAILED TO GIVE PRIOR WRITTEN NOTICE OF AND TO OBTAIN PRIOR WRITTEN AUTHORIZATION FROM HIS MEMBER FIRM TO ENGAGE IN SUCH ACTIVITIES.

ON APRIL 18, 1997, THE DECISION AND ORDER OF ACCEPTANCE OF OFFER OF SETTLEMENT SUBMITTED BY REPSONDENT CARNAGHI WAS ISSUED; THEREFORE, HE IS CENSURED, FINED \$40,000 AND BARRED FROM ASSOCIATION WITH ANY NASD MEMBER IN ANY CAPACITY.
