IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: THE CLIENT PURCHASED THREE VARIABLE ANNUITY CONTRACTS IN APRIL 2004. THE CLIENT ALLEGES THAT THE REPRESENTATIVE ASSURED HIM THAT SPECIFIC INVESTMENT MUTUAL FUNDS WITHIN THOSE ANNUITIES WERE SAFE FOR KEEPING HIS FUNDS. THE CLIENT FURTHER ALLEGES THAT THE REPRESENTATIVE DELIVERED ONLY TWO OF THE THREE CONTRACTS THAT HE PURCHASED AND NEVER INFORMED THE CLIENT OF THE 10-DAY FREE LOOK PROVISION OF THE CONTRACTS. THE CLIENT REQUESTS THAT THE THREE VARIABLE ANNUITY CONTRACTS BE TERMINATED AND THAT HE BE ALLOWED TO RECOVER LOSSES THAT HE ESTIMATES TO BE \$15,000.00.
