I REC'D A FIRM ORDER FROM THE CLIENT TO PURCHASE 400 SHARES OF SOUTHWEST AIRLINES WHEN I CALLED THE CLIENT BACK TO CONFIRM THE TRADE, THE CLIENT SAIF HE HAD CHANGED HIS MIND AND ALLGED THAT THE TRADE WAS UNAUTHORIZED. HE SAID THAT HE NEEDED THE MONEY TO PAY HIS TAX BILL. AN AWARD OF \$55.39 ON A \$10,000.00 CLAIM SHOWS I HAD ACTED PROPERLY AND PROFESSIONALLY.
