THE CLIENT OWNED AN ANNUITY THAT WAS NOT PERFORMING UP TO HIS EXPECTATIONS AND WAS NOT PURCHASED THROUGH ME. I ASKED MY ASSISTANT TO CALL THE ANNUITY COMPANY AND DETERMINE THE COST BASIS. BASED ON THE INFORMATION MY ASSISTANT GATHERED AND REPORTED, IT WAS MY UNDERSTANDING THAT THE COST BASIS ON THE ANNUITY WAS VERY CLOSE TO THE CURRENT MARKET PRICE AND THAT IF SOLD THE TAX CONSEQUENCE WOULD BE MINIMAL. I RECOMMENDED SELLING THE ANNUITY BASED ON THE BELIEF THAT THE TAX CONSEQUENCE WOULD BE MINIMAL AND I RECOMMENDED MUTUAL FUND INVESTMENTS THAT WERE IN LINE WITH THE CLIENT'S ECONOMIC BELIEFS. THE CLIENT WAS VERY HAPPY WITH THE CHANGES IN HIS ACCOUNT. HE FELT I HAD LISTENED TO HIS CONCERNS AND ADDRESSED THEM.

WHEN THE CLIENT RECEIVED HIS TAX STATEMENT IT SHOWED A LARGER GAIN THAN EXPECTED. UPON FURTHER RESEARCH I WAS ABLE TO DETERMINE THAT OUR ASSISTANT WAS ACTUALLY GIVEN THE CORRECT COST BASIS INFORMATION BY THE INSURANCE COMPANY. THE ANNUITY HAD BEEN PURCHASED FOR \$41,293 BUT THE COST BASIS WAS \$25,000 BECAUSE IT HAD BEEN ROLLED OVER FROM ANOTHER ANNUITY. UNFORTUNATELY MY ASSISTANT DID NOT UNDERSTAND THIS DISTINCTION.
