IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CFS RECEIVED A CLIENT COMPLAINT FORWARDED BY AN INSURANCE COMPANY REGARDING THE PURCHASE OF A VA THROUGH A CFS REPRESENTATIVE. CLIENT ALLEGED THAT THE FEATURES OF THE VA INCLUDING ITS GUARANTEED MINIMUM WITHDRAWAL BENEFIT (GMWB) OPTIONAL RIDER AND SURRENDER CHARGES WERE NOT PROPERLY EXPLAINED AND/OR DISCLOSED AT THE TIME OF ORIGINAL PURCHASE IN 2009. HOWEVER, AT THE TIME OF PURCHASE THE CLIENT SIGNED ACCOUNT DOCUMENTATION REFLECTING (I) THE BASIS OF SUITABILITY, AND (II) THAT FULL DISCLOSURE OF ALL APPLICABLE FEATURES INCLUDING FEES AND SURRENDER COSTS WAS MADE. ADDITIONALLY, HISTORICAL DOCUMENTED FILE NOTES REFLECTED NUMEROUS CONVERSATIONS BETWEEN REPRESENTATIVE AND CLIENT WHEREIN GMWB AND SURRENDER COSTS WERE REVIEWED. THE CFS REPRESENTATIVE DID NOT RECOMMEND OR FACILITATE THE FULL SURRENDER OF THE ANNUITY WHICH IT APPEARS MAY HAVE BEEN MOTIVATED IN PART BY THE CLIENT'S DESIRE TO WORK WITH A NEW BROKER AT ANOTHER FIRM. THE NEW BROKER MAY HAVE ALSO ASSISTED THE CLIENT IN SURRENDERING THE VA AS WELL AS TO TRANSFER THE PROCEEDS FROM SALE. ACCORDINGLY, CFS DENIED CLIENT'S ALLEGATIONS.
