### What is included in a IAPD report?

**Broker Statement** THIS CONCERNS A POLICY INCLUDED IN THE CLASS OF POLICIES THAT WAS THE SUBJECT OF A NATIONWIDE CLASS ACTION SETTLEMENT IN



WHICH PRUDENTIAL, ITS INSURANCE AFFILIATES AND PERSONNEL WERE RELEASED CONCERNING LIFE INSURANCE SALES PRACTICES. THE CLASS ACTION SETTLEMENT REMEDIATION PROCESSES FOR ADDRESSING CLAIMS FOR POLICIES INCLUDED IN THE CLASS HAVE CONCLUDED. BECAUSE THE COMPANY AND THE REPRESENTATIVE(S) WERE RELEASED FROM ANY FURTHER LIABILITY OR OBLIGATION WITH RESPECT TO CLAIMS LIKE THOSE MADE BY THE POLICYHOLDER, THE COMPANY IS NOT REVIEWING THIS INQUIRY AND IS MAKING NO FINDING OR FURTHER FILING REGARDING THIS INQUIRY. DURING THE TIME OF THIS COMPLAINT I WAS THE DISTRICT MANAGER OF THE AGENCY. MR. AND MRS. KRIZNICK HAD A FORMAL COMPLAINT WHICH I WAS REQUIRED TO HANDLE AS THE MANAGER. THE COMPANY HONORED THE COMPLAINT AND REFUNDED THE FUNDS TO THEM AND REVERSED THE INSURANCE POLICIES. WHEN I DELIVERED THE CHECKS TO THEM THEY WERE CONCERNED ABOUT LOSING THEIR INSURANCE AND ASKED ME WHAT THEY COULD DO. I SHOWED THEM A VARIABLE LIFE POLICY WITH A DROP IN OF \$16,000 (MOST OF THESE FUNDS WERE FROM THE MONEY PRUDENTIAL WAS PAYING BACK TO THEM) TO ADVANCE PAY THE PREMIUMS. I DELIVERED ALL REQUIRED PROSPECTUSES, MARKETING MATERIAL, AND LEDGER ILLUSTRATIONS AND CLEARLY EXPLAINED THE FUNDING OF POLICY THEY WOULD PURCHASE. I USED THE LEDGER ILLUSTRATION TO SHOW HOW IT WOULD WORK WITH VARIOUS CHARGES AND EXPENSES AND RATES OF RETURN. THEY PURCHASED THE COVERAGE AND EVERY YEAR FOR THE NEXT 3 YEARS I WOULD EXPLAIN TO THEM EVERY YEAR HOW IT WAS WORKING. I NEVER TOLD THEM TO DISREGARD ANY PREMIUM NOTICES. IN FACT WE HAD SEVERAL DISCUSSIONS ON PUTTING MORE MONEY INTO THE CONTRACT FUND. I EXPLAINED TO THEM EACH YEAR HOW ADVANCE PAYING THE PREMIUMS WAS WORKING FOR THEM AND THEY WERE VERY SATISFIED WITH THE POLICY. AFTER 1993 I MOVED INTO A DIFFERENT POSITION WITH THE COMPANY AND I AM NOT SURE WHAT HAPPENED ANNUALLY TO THE SERVICING OF THE POLICY OVER THE LAST 13 YEARS.
