What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

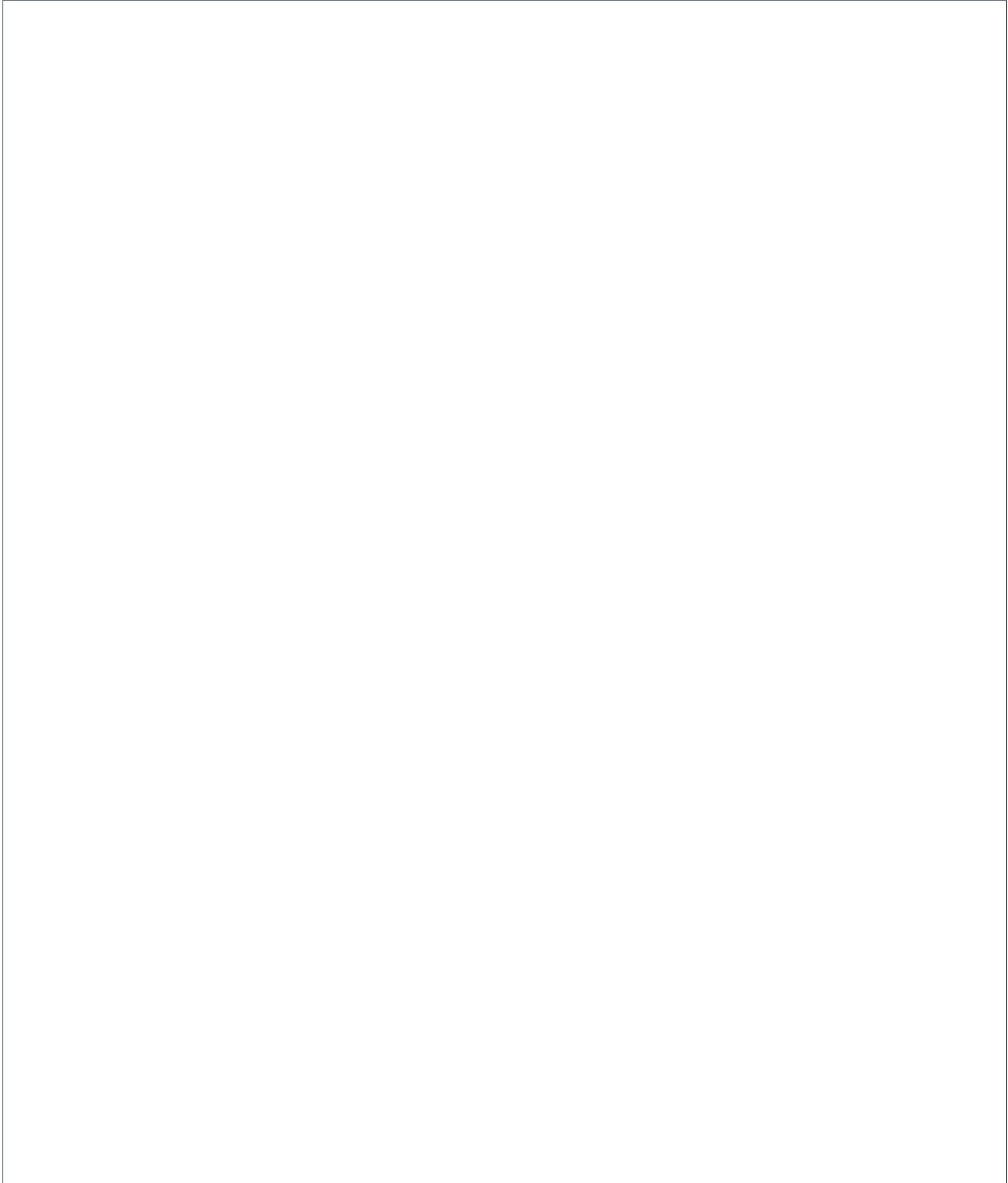

Broker Statement

COE MAGRUDER, AS BRANCH MANAGER OF DAVID GREENSPAN, DISCOVERED AND ALERTED CLAIMANT THEN REFUSED TO ACCEPT AGREED TO DAMAGES OF \$36,641. AFTER FILING THIS ARBITRATION, CLAIMANT ACCEPTED PAINWEBBER'S ORIGINAL OFFER OF \$36,641 AND WITHDREW ALL CLAIMS. PAINWEBBER AND COE MAGRUDER DENY AND WRONG DOING. CLAIMANT'S OWN ACCOUNTANT AGREED TO AN ACTUAL LOSS (INCLUDING INTEREST AND ACCOUNTANT FEES) OF \$36,641. PAINWEBBER OFFERED THIS AMOUNT TO CLAIMANT WHO REFUSED TO ACCEPT IT AND DEMANDED ADDITIONAL COMPENSATION. THE FILING OF THIS ARBITRATION WAS MOTIVATED SOLELY BY AGREED AS EVIDENCED BY CLAIMANT'S WITHDRAWL OF CLAIM. AT ALL TIMES, I CONDUCTED MYSELF IN A PROFESSIONAL AND APPROPRIATE MANNER. THIS EVENT SHOULD NOT APPEAR ON MY RECORD.
