Broker Statement Customer complaint was unsubstantiated since he would not respond to any requests for information. This was a back-office operational error by not following up with the other company to make sure the \$100 would transfer. Peter Coleman left the company shortly after submitting the paperwork, and the new advisor who inherited the account never followed up with account transfer to make sure the money was being exchanged over. Merrill Lynch Financial Advisors sent the customer a check for \$123.84 in the interest of good customer relations.
