CUSTOMER HAD GIVEN THIRD PARTY TRADING AUTHORIZATION TO THE RIA FIRM. THIS WAS SIMILAR TO THE ARRANGEMENT WE HAD AT BRAUER & ASSOCIATES. CUSTOMER LOST MONEY AND NEEDED A WAY TO RECOVER SO HE FILED A COMPLAINT WITH THE AID OF AN ARBITRATION SPECIALIST (NOT AN ATTORNEY). APPLICANT WAS DROPPED FROM THE COMPLAINT BEFORE ANY SETTLEMENT WAS REACHED.
