What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

U4 DISCLOSES BORK WAS NAMED A DEFENDANT IN AN ACTION ENTITLED COMMODITY FUTURES TRADING COMMISSION v. AMERICAN MONETARY INVESTMENTS, INC., GARY E. HALSTEAD, GARY WAYNE THOMPSON, KENNETH A. PALIN, AND MICHAEL BORK, FILED IN THE U.S. DISTRICT COURT FOR THE NORTHERN DISTRICT OF TEXAS, DALLAS DIVISION; CIVIL ACTION NO. CA3-84-0621R. THE ACTION WAS FILED IN APRIL 1984 AGAINST THE DALLAS BASED, PRIVATELY HELD, COMMODITY FIRM IN WHICH BORK HELD COMMON STOCK. THE FIRM, AMERICAN MONETARY INVESTMENTS, INC., SUBSEQUENTLY WENT OUT OF BUSINESS. THE TEMPORARY INJUNCTION PREVIOUSLY ENTERED AGAINST BORK WAS DISSOLVED AND HE WAS DISMISSED FROM THE ACTION BY ORDER DATED SEPTEMBER 27, 1985. (COPY OF COURT DOCUMENT DISMISSING THE ACTION REC'D)
