What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement THE SECURITY WHICH WAS THE SUBJECT OF THE [CUSTOMERS'] COMPLAINT WAS NOT INITIALLY PURCHASED THROUGH PRIMEVEST. RATHER, IT WAS TRANSFERRED FROM A PRIOR FIRM. THEY NEVER COMPLAINED ABOUT THE SECURITY DURING THIS ENTIRE PERIOD. SHORTLY AFTER I LEFT PRIMEVEST, I LEARNED THAT THEIR SON, WITH 20-20 HINDSIGHT, ALLEGED THAT THE SECURITY WAS UNSUITABLE. IT WAS THEIR SON, A SOPHISTICATED AND EXPERIENCED INVESTOR, WHO HAD USED HIS POWER OF ATTORNEY OVER HIS PARENTS' ACCOUNT TO PURCHASE MORE OF THE SUBJECT SECURITY JUST BEFORE THE HISTORIC MARKET DECLINE OF 2008, THEN COMPLAINED THAT IS WAS



UNSUITABLE.
