What is included in a IAPD report?

Where did this information come from?

Broker Statement	In 2015, based on meetings and conversations with the customers, I recommended and implemented, with their express approval, a retirement plan to generate income which would allow the customers to defer taking Social Security until age 70. Unfortunately several of the investments did not perform how I expected due to forces beyond my control. The customers filed the arbitration alleging that the investments were unsuitable. I denied, and continue to deny, any wrongdoing whatsoever. The arbitration was settled to solely to avoid the further costs of litigation.

**Broker Statement**

The claims in this case had no merit and were settled for a nominal amount to avoid the costs of litigation. The broker-dealer made the decision to settle, and the broker-dealer made the settlement payment. This couple was my client (along with a colleague) from December 2013 until I left the firm in March 2017. A full retirement plan was completed along with detailed investment option explanations. The investment proposal implemented was diverse including market protected investments, income producing investments, and growth investments. The market value of certain investments did not perform as expected, but the customers were aware of the risks and acknowledged those risks in writing.
