IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations: ON FEBRUARY 21, 2014, THE SECURITIES DIVISION ENTERED INTO A CONSENT ORDER WITH RESPONDENTS, ADAMS FINANCIAL CONCEPTS, LLC ("AFC"), A REGISTERED INVESTMENT ADVISER IN SEATTLE, WASHINGTON, AND ALEXANDER MICHAEL ADAMS ("ADAMS"), A REGISTERED INVESTMENT ADVISER REPRESENTATIVE. THE SECURITIES DIVISION ALLEGED THAT AFC WAS THE MANAGING MEMBER OF A HEDGE FUND WITH FOUR WASHINGTON LIMITED PARTNERS WHO INVESTED A TOTAL OF APPROXIMATELY \$2 MILLION. THE SECURITIES DIVISION ALLEGED THAT WHEN OFFERING AND SELLING THE LIMITED PARTNERSHIP INTERESTS AND WHEN PURCHASING INVESTMENTS FOR THE HEDGE FUND, RESPONDENTS FAILED TO DISCLOSE MATERIAL INFORMATION TO THE INVESTORS. WITHOUT ADMITTING OR DENYING THE ALLEGATIONS, RESPONDENTS AGREED TO PAY A FINE OF \$10,000, TO PAY INVESTIGATIVE COSTS OF \$5,000, AND AGREED THAT RESPONDENTS WOULD NOT HAVE CUSTODY OF ANY CLIENT FUNDS OR SECURITIES FOR A PERIOD OF TEN YEARS FROM THE DATE OF THE CONSENT ORDER.



RESPONDENTS EACH WAIVED THEIR RIGHT TO A HEARING AND TO JUDICIAL REVIEW OF THIS MATTER.
