**Allegations:** THE CLIENT STATES THEY PURCHASED \$200,000 OF DELL AT \$104 IN 2/99 BASED ON MR. MINICH'S RECOMENDATION AND PLACED A STOP LOSS AT \$90. THE CLIENT STATES MR. MINICH RECOMMENDED REMOVING THE STOP ORDER AS DELL WAS DECLINING DUE TO EARNINGS REPORT. THE CLIENT TRANSFERED OUT THE DELL ON 3/21 WHILE THE STOCK WAS AROUND \$54 AFTER A 2 FOR 1 SPLIT. CLIENT STATES THAT HE INSTRUCTED MR. MINICH TO LOOK AT VISX WHEN IT WAS TRADING IN THE HIGH \$50S, LOW 60'S. CLIENT STATES THAT MR. MINICH WATCHED VISX FOR 3 WEEKS AND THEN RECOMMENDED A BUY AT \$101. THE CLIENT STATES VISX HAS DROPPED INTO THE TEENS AND MR. MINICH SHOULD HAVE SOLD HIS STOCK WHEN IT WAS AROUND \$50. IN ADDITION, THE CLIENT STATES THE IR PUT FUNDS IN A SHORT-TERM BOND FUND AS OPPOSED TO THE MONEY MARKET FUND IN ATTEMPT TO MAKE UP LOSS FOR THE DELL MISTAKE.

### Broker Statement

MINICH STATES THE CLIENT EXPRESSED AN INTEREST IN INVESTING MORE AGGRESSIVELY THAN HE HAD BEEN WITH CDS AND DIRECTED THE PURCHASE OF DELL. MINICH STATES HE SUGGESTED ENTERING THE STOP-LOSS ORDER FOR DELL. MINICH STATES THE CLIENT INSTRUCTED HIM TO REMOVE THE STOP ORDER. MINICH STATES THE CLIENT APPROACHED HIM ABOUT VISX AFTER DISCUSSING IT WITH AN ACQUAINTANCE. MINICH STATES BECAUSE THE PRICE HAD RISEN DRAMATICALLY AT THAT TIME, MINICH MONTORED THE STOCK FOR APPROXIMATELY ONE MONTH. MINICH STATES STANDARD & POORS REITERATED THER "STRONG BUY" RECOMMENDATION AND THE CLIENT INSTRUCTED HIM TO PURCHASE 530 SHARES. MINICH STATES WHEN THE PRICE OF VISX BEGAN TO FALL HE RECOMM ENDED SELLING THE SHARES ON NUMEROUS OCCASIONS. IT APPEARS MINICH MADE SUGGESTIONS BASED ON DISCUSSIONS WITH THE CLIENT AND ALL TRADES WERE AUTHORIZED. CLAIM RESPECTFULLY DENIED.
