### Where did this information come from?

### Customer Dispute

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. **Reporting Source:** Individual

**Employing firm when activities occurred which led to the complaint:** LIBERTY CAPITAL INVESTMENT CORPORATION

**Allegations:** A claim was filed against Liberty Capital Investment Corporation by clients who reside outside of the United States. The claim alleged Liberty Capital permitted extended family members of the account holders to withdraw funds without the account holder's permission, despite said family members having Power of Attorney and Liberty Capital having signed instructions for the transactions. Robert Walker and Gary Purpura were not named as respondents in the claim, but the claim represented they were the individuals responsible for the accounts at issue. Liberty continues to assert that the claims are false, and that Liberty acted only upon signed documentation for each of the transactions. In order to avoid the expense of further litigation not covered by insurance, Liberty has settled in mediation for a fraction of the original claim without admitting any wrongdoing. Robert Walker and Gary Purpura did not contribute to the settlement.
