IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THIS CLIENT'S ALLEGATIONS WERE ABSOLUTELY UNSUBSTANTIATED, AS INVESTMENT ADVICE WAS ALWAYS PROVIDED BASED ON THE CLIENT'S GOALS AND INVESTMENT PREFERENCES, MEETING ALL SUITABILITY REQUIREMENTS. (AFTER TALKING WITH THIS CLIENT IN MAY, 2000, HE ACTUALLY APOLOGIZED AND REQUESTED THAT I CONTINUE TO BE HIS INVESTMENT BROKER.) THE SETTLEMENT MADE BY J.C. BRADFORD & CO., WHICH INCLUDED LIQUIDATING THE ENTIRE INVESTMENT FOR THE CLIENT, WAS MADE TO AVOID THE UNCERTAINTIES, TIME, AND COST ASSOCIATED WITH THE ARBITRATION PROCESS, SINCE ON APRIL 28, 2000, PAINWEBBER GROUP HAD ANNOUNCED ITS INTENTIONS TO ACQUIRE J.C. BRADFORD & CO. I WAS NOT INFORMED THAT THIS MATTER HAD BEEN SETTLED AND WAS NOT ASKED TO PERSONALLY CONTRIBUTE ANY MONIES TOWARD ITS SETTLEMENT.
