IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THEY FURTHER ALLEGE THAT EKS PROVIDED NO INFORMATION ON THE 2007 MERGER WITH ACCESS WEALTH MANAGEMENT, WHICH IS FALSE, AND EKS OPENED A MARGIN ACCOUNT WITHOUT CLIENT AUTHORIZATION, WHICH IS ALSO FALSE. I KNOW THE CLAIM IS COMPLETELY DEVOID OF MERIT, AND I INTEND TO DEFEND MYSELF VIGOROUSLY.

IN 2006 EKS DEVELOPED A FINANCIAL PLAN WHICH SHOWED THAT CLIENTS WISHED TO RETIRE IN 7 YEARS AND THAT THEIR SIGNIFICANT INVESTMENTS COULD GROW AND PROVIDE FOR THEM OVER THEIR LIFETIMES. CLIENTS AUTHORIZED PURCHASE OF INVESTMENTS RECOMMENDED IN THE PLAN TO ACCOMPLISH THEIR LONG-TERM GOALS. AT THE SAME TIME, CLIENTS UNEXPECTEDLY BEGAN TO WITHDRAW LARGE SUMS OF THE CASH THAT WAS ALLOCATED FOR THOSE INVESTMENTS, WHICH THREW THEM INTO A MARGIN POSITION. ACCOUNT WAS OPENED AS MARGIN SOLELY FOR CLIENT'S PURPOSES TO HOLD THEIR RESTRICTED SHARES OF CERTAIN STOCK. CLIENTS WERE UNRESPONSIVE WHEN CONTINUALLY ADVISED TO PAY DOWN GROWING MARGIN BALANCES CAUSED BY THEIR REGULAR WRITING OF LARGE CHECKS AGAINST THE INVESTMENTS. AMOUNT OF CLIENT WITHDRAWALS IS EQUAL TO INITIAL AMOUNT OF ACCOUNT. CLIENTS CLEARLY WITHDREW THEIR FUNDS AND EXHAUSTED THEIR ACCOUNT. THEY NOW WISH TO REPLENISH THOSE FUNDS AT THE EXPENSE OF EKS THROUGH AN ARBITRATION AWARD.
