What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

Both the Firm and the RR firmly refute the allegations. Clients authorized the purchase of the security in question. Purchases were made in 2019 and 2020, not 2022 as alleged. Additionally, clients received initial trade confirmations, were provided over 100 account statements since the purchase all of which showed the position in question, and cashed over ten dividend checks paid to them from the preferred stock. Clients did not raise any concerns between the purchases in 2019-2020 and the first written complaint received in 2024 despite having received statements, dividends, making additional purchases, and meeting with the RR. Claim denied as lacking merit.
