I BELIEVE THAT THE COMPLAINT AGAINST ME WAS ENTIRELY WITHOUT MERIT AND I DENY ALL ALLEGATIONS OF WRONGFUL CONDUCT WITH RESPECT TO THAT ACCOUNT.
