IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	I REQUEST THAT MY NAME BE REMOVED FROM THIS MATTER. I ATTENDED SEVERAL MEETINGS WITH CLIENTS TO PROVIDE AN OVERVIEW OF THE MDM GROUP AND UBS'S MARKET PERSPECTIVE. I HAD NO DIRECT INVOLVEMENT IN THE CLIENT'S FINANCIAL PLAN, ASSET ALLOCATION, INVESTMENT SELECTION OR ON GOING ADJUSTMENTS. A REVIEW OF THE COMPLAINT SHOWS THAT I WAS NOT MENTIONED IN THE KEY CONVERSATIONS AND ISSUES IN DISPUTE. IN NOVEMBER OF 2008, (AFTER THE CLIENTS LIQUIDATED A BULK OF THEIR PORTFOLIO). I ASSISTED THE CLIENTS TO IMPLEMENT A BOND INVESTMENT STRATEGY AT THEIR DIRECTION. THIS RELATIONSHIP CONTINUED UNTIL THE ARBITRATION WAS FILED AND THEIR ACCOUNTS WERE TRANSFERRED IN OCTOBER 2009. NO ISSUES ARE IN DISPUTE THIS PERIOD. THE FINANCIAL ADVISORS WERE NOT NAMED AS RESPONDENTS. UBS MADE A BUSINESS DECISION TO SETTLE THIS MATTER FOR POTENTIAL COST OF LITIGATION AND NOT BECAUSE OF ANY WRONGDOING ON THE PART OF THE FINANCIAL ADVISORS. CLAIMANTS' ASSETS WERE ALLOCATED UNDER A LONG TERM PLAN WHEN CLAIMANTS CHOSE TO GET OUT OF THE MARKET AT THE BOTTOM. CLAIMANTS' LOST SOME OF THEIR EARLIER GAINS. THE FINANCIAL ADVISORS WERE NOT ASKED TO CONTRIBUTE TO THE SETTLEMENT.
