[TOP] ON 11/6/95, DISTRICT NO. 5 NOTIFIED TODD A. CONNELLY, ET AL. THAT THE LETTER OF ACCEPTANCE, WAIVER AND CONSENT NO. C05950058 WAS ACCEPTED: THEREFORE, RESPONDENT MCGIBBONY IS CENSURED, FINED \$5,000, SUSPENDED FROM ASSOCIATION WITH ANY NASD MEMBER IN ANY PRINCIPAL CAPACITY FOR 30 DAYS, AND ORDERED TO REQUALIFY AS A GENERAL SECURITIES PRINCIPAL BY TAKING AND PASSING THE APPROPRIATE EXAMINATION WITHIN 90 DAYS OF ACCEPTANCE OF THIS LETTER OF ACCEPTANCE, WAIVER AND CONSENT.
