IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: Clients allege that their financial professional did not properly explain the terms of the Jackson National Annuity they purchased approximately ten years ago. The clients indicated they invested in the Annuity based on the financial professional's explanation of the Guaranteed Withdrawal Balance. Their understanding was that after an 11 year waiting period, the initial investment would yield an additional 4% return. The clients also allege that the annuity was not a suitable investment due to its fee structure and believe the annuity is unnecessary due to their other guaranteed streams of retirement income. The clients allege damages of 'at least' \$15,000.
