### Where did this information come from?

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Based on litigation received 3/2017 involving the original selling and service agent, AXA Advisors, and Robert Woodcock in his role as an EVP and Sales Manager with the Firm, all parties agreed to a settlement of \$700,000.
