COMPLAINT IS BEING ADDRESSED BY THE COMPLIANCE DEPARTMENT OF AN AFFILIATED INSURANCE COMPANY, ING(RELIASTAR). ADDITIONALLY, CLIENTS' COMPLAINT IMPLICITLY ASSERTS THAT THEY DID NOT KNOW/REALIZE THAT THE ING VARIABLE LIFE INSURANCE POLICIES WERE "NEW POLICIES" REQUIRING "BASICALLY STARTING OVER" ON THEIR PART AND THEY CLAIM THAT THEIR PREVIOUS POLICIES WOULD HAVE BEEN "PAID UP" IN MAY OF 2006 AND MAY OF 2008. ALSO CLAIM TO HAVE TOLD REP "ON SEVERAL OCCASIONS" OF DESIRE TO PURCHASE ROTH IRAS ONCE THEIR VL POLICIES WERE "PAID UP".

AFFILIATED INSURANCE COMPANY, ING (RELIASTAR), RESPONDED TO COMPLAINT VIA A LETTER MAILED ON 8/3/06 WHERE IN AN EXPLANATION OF ALL OF THE INFORMATION THAT HAD BEEN DISCLOSED TO THE CLIENTS WAS PROVIDED. THE LETTER ALSO NOTED THAT NOTHING HAD BEEN PROVIDED OT THE CLIENTS INDICATING THAT THE ING VARIABLE LIFE INSURANCE POLICIES WERE IN ANY WAY A CONTINUATION OF THEIR PREVIOUS POLICIES. RATHER, IT WAS EXPLAINED THEY HAD RECEIVED AND/OR COMPLETED MULTIPLE DOCS THAT MADE IT CLEAR THEY WERE PURCHASING NEW POLICIES AND TERMINATING PREVIOUS POLICIES.
