IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: IN CONTINUING CORRESPONDENCE DATED SEPTEMBER 23, 2004, CLIENTS' ATTORNEY CLAIMS THAT THERE WERE "MISREPRESENTATIONS MADE TO THE CUSTOMERS IN THE MEETINGS BEFORE THE CUSTOMERS OPENED THEIR ACCOUNTS WITH UBS" AND "PURCHASE[S] OF UNSUITABLE INVESTMENTS." TIME PERIOD IS 2003. IN CONTINUING CORRESPONDENCE DATED AUGUST 6, 2004, CLIENTS MAKE A DEMAND FOR COMPENSATION IN CONNECTION WITH COMPLAINT. TAKEN IN COMBINATION WITH PRIOR CORRESPONDENCE WHICH ALLEGED THAT CLIENTS REQUESTED A REDUCTION OF THEIR EQUITY INVESTMENTS, BUT "THAT AT NO TIME DID THE RATIO OF EQUITIES COME DOWN TO THE REQUESTED 30% LEVEL." CLIENT ALSO ALLEGED THAT HE "BOUGHT SHARES OF A BOND FUND" AND THAT WHEN LATER HE "REQUESTED THAT THE ASSETS BE LIQUIDATED . . . THE SHARES WERE SOLD CAUSING A SIGNIFICANT PENALTY" WHICH SHOULD HAVE BEEN BROUGHT TO HIS ATTENTION PRIOR TO THE LIQUIDATION. TIME PERIOD IS 2003. DAMAGES ESTIMATED TO EXCEED \$5000.00.
