IT. MY STANDARD PRACTICE FOR MANY YEARS HAS BEEN TO KEEP A TELEPHONE DIARY ON A DAILY BASIS WHICH INCLUDES EVERY MESSAGE THAT COMES INTO MY OFFICE VOICEMAIL. I USE THE OFFICE VOICEMAIL AS A SCREENER SO THAT I CAN PRIORITIZE ALL OF MY CALL BACKS. I KEEP THE TELEPHONE DIARY IN A SERIES OF SPIRAL NOTEBOOKS WHICH I AM WILLING TO PUT ON DISPLAY FOR ANYONE INTERESTED. THIS SHOWS THAT THE CLIENT DID NOT CALL. FROM MY TELEPHONE DIARY I HAVE RECONSTRUCTED THE SERIES OF EVENTS FROM 9/17/07 THROUGH 12/29/08. IN LATE '07 I RECEIVED CALLS FROM THE CLIENT'S PARTNERS REGARDING THEIR PERCEPTION OF HIS INTENT. I AM NOT ABLE TO TRADE ON ANYONE'S INSTRUCTIONS OTHER THAN THE ACCOUNT OWNER(S). I RECEIVED NO CALLS IN OCTOBER OR NOVEMBER OF '07, AND NOT UNTIL THE EVENING OF 12/26/07 DID I HEAR FROM THE CLIENT, AND AT THAT TIME I COMPLIED WITH HIS REQUEST TO SELL ON ONE ACCOUNT. HE DID NOT REQUEST THE LIQUIDATION OF ANY OTHER ACCOUNT, EXCEPT HIS SEP. UPON RESEARCH, THE CLIENT INDEED RECEIVED A STATEMENT FOR ALL OF HIS ACCOUNTS EVERY MONTH FROM OCTOBER 2007 THROUGH OCTOBER 2008. THE CLIENT RECEIVED A CONFIRMATION FOR EACH EXECUTED TRADE IN JANUARY 2008. I HAD NO COMMUNICATION FROM THE CLIENT IN 2008, UNTIL OCTOBER 9, 2008 WHEN HE RECEIVED A CONFIRMATION NOTICE THAT HIS INVESTMENT HAD MATURED AND LEFT ME A MESSAGE STATING THAT HE THOUGHT HE WAS OUT OF THE MARKETS. HE ALSO SAID HE HAD LOST \$10,000 AND THAT HE HAD SOME RESPONSIBILITY HERE FOR NOT CHECKING HIS ACCOUNT STATEMENTS, "BUT OH WELL, I LOST \$10,000."
